HEALTH & SAFETY REVIEW

The theme for this year's Health & Safety Review conference – Connected Health and Safety Enhances Wellbeing and Performance – reflects the HSA's view that occupational health is its number one priority, as set out in its new Strategy Statement 2016-2018. This means that HSA inspectors will be focussing their attention on work-related health risks.

The HSA's priority fits within the Government's Healthy Ireland Framework and the proposed Health and Wellbeing (Workplace Wellbeing) Bill.

But an even more important reason to give health priority in the workplace is that work-related ill-health results in more absence from work than workplace injuries, according to the available data. Employers need to address the health issues of the workplace: be they traditional issues like ergonomics and occupational hygiene or the modern issues of flexible work, bullying, harassment, stress, mental health and productivity problems associated with these issues.

Now that the connection is being made between health and safety, it is important to look at how occupational health and safety is managed in the workplace and the consequences of failure to manage. The conference will hear presentations on what can be achieved by putting in place policies to improve performance, but also what can befall organisations who fail to put good policies in place: injuries, illnesses, enforcement action by the HSA and increased insurance premiums.
